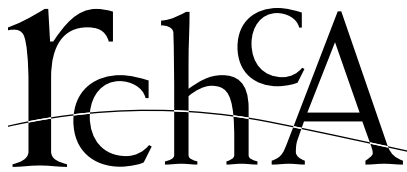

Train Noise Update

Two important actions have occurred recently. First, the county DOT (formerly DPWT) completed a supplemental study to the 2006 study, in this case focusing on the technology of hard plastic "lane separators" used elsewhere in Quiet Zones. The previous study assessed and rejected using median barriers made of concrete because usage would have required widening the road leading to the tracks. In contrast, the lane separator system analyzed here would not have this requirement, and in fact would only cost about \$14,000 installed. Based on the results of this study, Traffic Chief Wolanin is now supportive of having a Quiet Zone at this location, and is writing a letter to the County Executive, asking him to concur with the Quiet Zone concept and begin the application process with the Federal Railroad Administration. Since the process of establishing a new Quiet Zone (as opposed to a "grandfathered" one) is a first time exercise in Maryland, it remains unclear whether or not a public hearing will need to be held specifically on this project. Given the 8 year history of bureaucratic indifference and sometimes hostility toward the concept of Quiet Zones, we should not be complacent.

In order to facilitate this process, Delegates Al Carr and Jeff Waldstreicher and Senator Madaleno held a hearing for a bill that would permit the county to install "automated enforcement systems" at railroad grade crossings. The thought was that if safety concerns surface again to thwart momentum toward establishing a Quiet Zone, such a law would permit automated cameras to be installed near the tracks and deter cars from illegally driving around a lowered gate arm in order to "beat the train". I gave testimony in support of this bill on December 11. Other associations whose representatives also signed up to support the bill include Rock Creek Hills Homeowners Association, Glen Manor Condominium Association, Glen Briar Condominium Association, and Forest Glen Station Home Owners Association. There was no opposition voiced at the hearing.

Speaker from WSSC for January Meeting

Several Guest Speakers from WSSC will join us at our Winter meeting to discuss the Bi-County Water Supply Project. This undertaking will include a huge underground pipe (twelve feet in diameter). The pipe will run from the water works at the Potomac River, across Montgomery County, and finally to Prince George's County. The WSSC is planning to start construction in 2009; the project is expected to take five years. It is our understanding that a significant amount of this work will be near the RCHCA area.

We have asked the WSSC to include a short discussion on the history of this project, the need for and ultimate capability of the system, special problems, and estimated costs and sources of money. The most important part of the talk will be a detailed discussion of the effects of this project on our local environment. For instance, the many effects of digging large deep holes in the area, trucks moving dirt and stone (and where will it go), effects on our water, gas, electric and other facilities, noise, dust and night work, and the time the construction will be in our area. Questions will be encouraged.
